Guidance on Assessment

1- Practical observation

2- Written/Oral questioning

Oral questioning can be used to extract further information for these questions during the practical assessments, with the tutor documenting the responses or when needing, to supplement learners' written responses, according to individual learners needs. The recording of assessment will be via our awarding body.

This qualification lasts the period of 1 year, at which point candidates will need to attend a refresher course to refresh their knowledge and be updated on new procedures.
